### Meet Dr. Firdoos





## WE ARE DELIGHTED to announce that Dr. Saima Firdoos is our new Chief Medical Officer.

Dr. Firdoos was an Assistant Professor of Internal Medicine at Tufts University School of Medicine at Portsmouth Regional Hospital in New Hampshire. She is a Post Doc Fellow in Hepatology from BIDMC Harvard Medical School and was a Resident in Internal Medicine at St. Elizabeth Medical Tufts University in Boston, where she also did her internship in Psychiatry. Her research includes Hepatitis-C & non-alcoholic fatty liver disease during her Postdoctoral Training at Harvard Medical School.

When Dr. Firdoos first came into contact with Ritter Center, she didn't even know she was looking for a job. She was conducting research and brainstorming the types of health center she wanted to open herself. But, as she started talking to Ritter Center,

Dr. Firdoos realized that the intersection between what she wanted to create and where she might go to learn more about holistic health to ignite social change would be taking on the role of Chief Medical Officer.

Born in a Pakistan village, Dr. Firdoos was the sixth child and the 5th girl born into her family. "My mother had to go through tremendous opposition for sending her first born daughter to school which required one to walk several villages to even get there. My uncles would burn her books to discourage her, resulting in my other two sisters not going to school at all. My very brave mother left the village, sold her property and jewelry and made sure that my oldest sister continued her education. The local principal spotted me at age 3 and said I could come to school for free. In my community, the choice was either teacher or doctor. These were the only two choices my family would respect. The cultural pressure was tremendous. I chose doctor, of course!"

"Studies have shown that living on the streets shortens your life expectancy significantly. I've learned that the majority of those experiencing homelessness in San Rafael and Marin are from right here.

Any preconceived notions I had about those experiencing homelessness have shifted; the scope is larger than I initially thought in terms of population and challenges. I understand that when your primary focus is figuring out where your next meal is coming from, or where you will spend the night, **it is all about how to survive**," said David.

Today, David is recently retired, and after serving 7 years on Ritter's board under the amazing leadership of Margaret Trezevant, it seemed again like the right time to make a move – this time as Board President.

## **The Casa Azul Society Launches**

OVER THE YEARS, Central and South American immigrants making their way to San Rafael were advised to go to "the blue house," or Casa Azul, when they arrived in the Bay Area with no place to stay and few personal belongings. Ritter Center would help them with food, clothing and other support as they began their new lives.

Although our casa is now amarillo (yellow), Casa Azul is still synonymous with Ritter Center and the perfect name for our legacy society -- the group of people who have designated Ritter Center a beneficiary of their estate or planned gift.

#### What is a planned gift?

Forward-thinking donors often name Ritter Center as a beneficiary of their will, a trust or charitable gift annuity, life insurance policies, or real property. ## "Is My Child Alive?"



SAN RAFAEL Police Department Mental Health Liaison licensed marriage and family therapist Lynn Murphy plays a critical role in our community.

"When I talk to families, they want to know if their child is alive. They haven't heard from their son or daughter in two months. I get calls every week like this. Imagine if we could talk about mental health to shatter the stigma, eliminate the shame and get rid of the fear," says San Rafael Police Department Mental Health Liaison licensed marriage and family therapist Lynn Murphy. "There is a power in sharing your story. You are not alone."

Lynn was hired in 2013 to be a point of connection for people experiencing homelessness and/or mental health issues. Lynn got to know people, listened to their stories, and developed relationships with people on the street. Over time, these relationships included service providers like Ritter Center, too. From that, she grew an even stronger network of connections with the District Attorney's office, the court system, and the Public Defender's office. She has continued the work started by Dr. Joel Fay, a former officer with SRPD, to connect people to needed services as opposed to traditional criminal justice interventions.
